3. Information we collect and how we use it

Whether you are a customer of Aha! Insights Technology or an interested visitor to our Site, we may collect certain types of information:

1. Information you provide – When you seek to use Aha! Insights Technology's services through the Site, we may ask you for personal information (such as your name, phone number, mobile phone number, email address and an account password). For certain services, we may also request credit card or other payment account information which we maintain in encrypted form on secure servers. We may share your credit card information with a financial institution to facilitate your purchase of our services using your credit card. To the extent you provide us with

email addresses of third parties to facilitate use of our services, we will not disclose the addresses you provide to any third party, but may use such addresses to communicate with such third parties regarding our services.

2. Cookies – When you visit the Site, we send one or more cookies – a small file containing a string of characters – to your computer that uniquely identifies your browser. We use cookies to improve the quality of our service by storing user preferences and tracking user trends on our Site. We do not use cookies to track your actions outside of the platform.
3. Log information – When you access Aha! Insights Technology services, our servers automatically record information that your browser sends whenever you visit our website. These server logs may include information such as your web request, Internet Protocol address, browser type, browser language, the date and time of your request and one or more cookies that may uniquely identify your browser.
4. User communications – When you send email or other communications to Aha! Insights Technology, we may retain those communications in order to process your inquiries, respond to your requests and improve our services.
5. Affiliated sites – We may offer some of our services in connection with other web sites or mobile applications. You can decline to submit personal information regarding some of our services, in which case Aha! Insights Technology may not be able to provide those services to you.

5. Information sharing
